The International Organization for Migration in Libya **Operator Proficiency in Fast Rescue Boats**

16-27 July 2023 – Benghazi, Libya

1. Context

The International Organization for Migration (IOM) works in close partnership with Libyan authorities to enhance their capacity to respond to the challenges related to migration management. IOM takes up the role of promoting the orderly and humane management of migration, promoting international cooperation on migration issues, supporting relevant actors to govern migration flows and effectively maximize their positive impacts while minimizing the potential costs on migrants and society, as well as providing humanitarian assistance to migrants in need.

In search of a better life and opportunities, thousands of migrants continue to undertake perilous Mediterranean crossing every year, a journey that continues to claim the lives of many migrants, causing fatal injuries and scarring rescuers.

عدد الوفيات والاختفاءات التي تم التبليغ عنها وبالضرورة The central Mediterranean route has the highest number of reported deaths and disappearances worldwide and requires safe, effective, and efficient search and rescue (SAR) operations.

As Libyan authorities are increasingly called upon to save lives in the Mediterranean, specific training on taking charge of a lifeboat in emergencies is essential.

In this context, and to support the Libyan authorities in carrying out safe SAR operations, IOM Libya is proposing a ten-day training course titled: "Operator Proficiency in Fast Rescue Boats (FRB)".

1. السياق

تعمل المنظمة الدولية للهجرة (IOM) في شراكة وثيقة مع السلطات الليبية لتعزيز قدرتها على الاستجابة للتحديات المتعلقة بإدارة الهجرة. كما تضطلع المنظمة الدولية للهجرة بدور تعزيز الإدارة المنظمة والإنسانية للهجرة، وتعزيز التعاون الدولي بشأن قضايا الهجرة، ودعم الجهات الفاعلة ذات الصلة لإدارة تدفقات الهجرة وتعظيم آثارها الإيجابية بشكل فعال مع تقليل التكاليف المحتملة على المهاجرين والمجتمع ، فضلا عن تقديم المساعدة الإنسانية للمهاجرين المحتاجين.

يواصل آلاف المهاجرين القيام برحلة عبور البحر الأبيض المتوسط المحفوفة بالمخاطر كل عام بحثا عن حياة وفرص أفضل، وهي رحلة مازالت تودي بحياة العديد من المهاجرين، وتتسبب في إصابات قاتلة ومشاكل لرجال الإنقاذ.

يعتبر مسار البحر الأبيض المتوسط هو الاكبر عالمياً من حيث يتطلب عمليات بحث و إنقاذ آمنة و فعالة.

مع تزايد مسؤوليات السلطات الليبية لإنقاذ الأرواح في البحر الأبيض المتوسط، يعد من الضروري توفير تدريب خاص على تولى مسؤولية قارب النجاة في حالات الطوارئ.

في هذا السياق، ولدعم السلطات الليبية في تنفيذ عمليات البحث والإنقاذ الآمنة، تقترح المنظمة الدولية للهجرة في ليبيا دورة تدريبية لمدة عشر أيام بعنوان: " اتقان تشغيل قوارب الانقاذ السريعة ".





2. Objectives of the training

The ten-day training will aim to enhance participants' capabilities on:

- Operate a fast rescue boat on open water in a safe and effective manner.
- Conduct a sector and a creeping line search in reduced visibility for a crew overboard.
- Use a GPS as a compass to find a specific location.
- Participate in the capsize, getting out from under an FRB and the righting of an FRB as well as look after a passenger or an injured passenger during this activity.
- Use communication and signaling equipment.
- Operate the FRB in various sea and swell conditions.
- Recovering rescue boats.

4. Methodology

The training will follow a participatory methodology, encouraging interactive discussions and sharing of best practices.

5. Proposed participants

IOM proposes the attendance of the following participants: from Ministry of Interior:

• Fifteen (15) officers from the General Administration for Coastal Security (GACS)

6. Dates, location, and venue

The ten-day training will be held in Benghazi, from 16-27 July 2023. The venue will be shared at a later stage.

 - استخدام معدات الاتصالات والإشارات.
- تشغيل قوارب الانقاذ السريعة في مختلف ظروف البحر.
 - استعادة قوارب الإنقاذ.

4 المنهجية

وسيتبع التدريب منهجية تشاركية، تشجع المناقشات التفاعلية وتبادل الخبرات.
